CARE OF LOTS

- If any tree or shrub situated on any lot, shall be deemed detrimental by the Board of Trustees, they shall have the right, and it shall be their duty to have such tree or shrubs, or such parts thereof as may be by them deemed dangerous, detrimental, or inconvenient, removed, provided the owner shall first have due notice, if possible, to locate the owner.
- 2. All lots set with grass, or sodded, and not unnecessarily encumbered with shrubbery, or otherwise, shall be kept in clean order free of expense to the owner.
- 3. All graves are to be level or reasonably so, for easy moving, and sodded over.
- 4. The grading of all lots must be under the direction of the Superintendent and his employees. NO work or improvement of lots or graves will be permitted by any outside party.
- 5. No wooden benches, chairs, settees, headboards, wooden articles, ornamental objects such as sheperds hooks, or fences of any kind allowed on the ground.
- 6. Potted plants, permanent and artificial bouquets, sprays, wreaths, etc. will be permitted only from November 1st to April 1st. To aid in maintaining the beauty of the grounds from April 1st to November 1st each year all artificial bouquets, potted plants, wreaths, etc. along with perishable flowers, potted plants, glass and pottery containers will be removed; except Memorial Day, Mother's Day, and Father's Day the forementioned will be allowed, but must be removed within one week (7 days) or the cemetery Superintendent will remove them. With the following exceptions: Where the flowers are placed in a vase on the top of the foundation at the head and the wreath is placed on the monument in a manner to keep it from blowing off, permitting the grass to be cut without interfering with the workers mowing the grass. Flowers will be removed when unsightly.
- 7. Bottles, cans, boxes, etc. are regarded as objectionable and shall not be permitted to remain if placed on a lot or grave but shall be removed and destroyed.
- 8. The Board of Trustees disclaim any responsibility for the theft, or disappearance of any flowers, baskets, wreaths, vases, etc. and reserves the right to remove any natural or artificial flowers or other decorations, when in the opinion of the Superintendent, it becomes desirable to do so.
- 9. Trees within the cemetery borders shall not be cut down or destroyed without the consent of the Board of Trustees.

MISCELLANEOUS

- 1. For schedule of charges, consult the price list in effect with either the Superintendent or the Township clerk.
- 2. The cemetery employees, except the special employees hired to cut grass during summer months, will be in a work uniform designating them as township employees at all times when a funeral service is being conducted at the cemetery. By identifying the employees in such a manner, this should help the visitors to know who to approach when seeking information pertaining to the cemetery.
- 3. Any property belonging to this cemetery is not to be loaned to anyone.
- 4. The cemetery will not be responsible for anything that may be lost, misplaced, broken or stolen.
- 5. Every lot owner shall keep in good repair any monument or other structure which he or she may have on the lot.
- 6. The cemetery Board (Board of Trustees) has the power to settle all matters in dispute and its findings shall be final.
- 7. The Cemetery Board reserves and shall have the right to correct any errors that may be made by either in making interments, disinterments or removals, or in the description, transfer or conveyance of any interment property, either by cancelling such conveyance and substituting and conveying in lieu thereof other interment property of equal value and similar location as far as possible, or as may be selected by the Board, or in sole discretion of the Board by refunding the amount of money paid on account of said purchase. In the event such error shall involve the interment of the remains of any person in such property, the Board reserves and shall have the right to remove and/or transfer such remains so interred to such other property of equal value and similar location as may be substituted and conveyed in lieu thereof.
- 8. For graveside services, the cemetery shelter tent will be set up over the grave site for any services where there seems to be any danger of rainfall. If a tent is requested for any reason other than the above (rainfall) then a fee will be charged for the service.
- 9. In making burials, removals, disinterments and excavations and in the erection of markers, monuments, and memorials, the Board reserves the right to use temporarily the adjacent lot or lots for such tools, derricks and materials as are necessary to perform the work.
