I further acknowledge alcoholic beverages are prohibited on the grounds of Cleves Community Park, except at special permitted events/areas. I agree not to give or sell any alcoholic beverage to any individual or participate in the sale of alcoholic beverages on the grounds of Cleves Community Park, except at special permitted events and/or areas.

I further acknowledge that the Village of Cleves assumes no responsibility for lost or stolen articles during any event held in Cleves Community Park.

## Park Rules & Regulations

- ∅ The Village of Cleves reserves the right to close the park to the public at any time.
- ∅ Field closings will be at the sole discretion of the Village of Cleves.
- ∅ A yearly or daily pass is required to be given entry into the park for any reason.
- ∅ Scheduling of sports activities must be done with the approval of the Village of Cleves.
- ∅ Permit holders will have first right for fields/ areas/ shelters they have been assigned. Fields/ areas/ shelters not reserved will be available to the public on a first-come, first-serve basis.
- ∅ Parking is only permitted in the designated areas. **NO PARKING ALLOWED** on the Hike/Bike Trail.
- ∅ Coolers are prohibited.
- ∅ No glass or alcoholic beverages of any kind are allowed.
- ∅ Please keep pets on a leash at all times while in the park.
- ∅ Please pick up after your pet.
